

# Rocky Mountain Health Plans Quarterly Electronic Clinical Quality Measures

Quarterly Electronic Clinical Quality Measures (eCQMs) reporting is required for all of Rocky Mountain Health Plans (RMHP) value-based programs Regional Accountable Entity (RAE), RMHP Advanced Alternative Payment Model (APM), and Payment Reform Initiative for Medicaid enrollees (PRIME) as well as RMHP internal quality improvement programs (Foundations, Masters I and Masters II). Practices must report eCQM data for all measures that can be pulled and validated from a certified EMR or registry, Quality Health Network (QHN) eCQM Solution Tool (Diameter Health Registry) and/or Contexture eCQM data. If you would like to report QHN or Contexture data for RAE, submit in the RMHP eCQM reporting tool and indicate the data source in the comments column.

## Reporting requirements

<b>RAE and RMHP advanced alternative payment model practices</b>	<ul style="list-style-type: none"> <li>• Report eCQM data for all measures able to be pulled and validated from a certified EMR or registry, QHN and/or Contexture eCQM data</li> <li>• Must meet minimum required eCQM benchmarks based upon tier status</li> </ul>
<b>PRIME</b>	<ul style="list-style-type: none"> <li>• Report <b>CMS 137</b> initiation and engagement of substance use disorder treatment (part A and B)</li> <li>• Report <b>CMS 2</b> depression screening and follow-up</li> <li>• Report <b>CMS 122</b> diabetes: hemoglobin A1C (HbA1c) poor control (&gt;9%)</li> <li>• Pediatric practices are excluded from CMS 122 requirement</li> </ul>
<b>Foundations, Masters I and Masters II</b>	<ul style="list-style-type: none"> <li>• Report eCQM data for all measures able to be pulled and validated from a certified EMR or registry, QHN and/or Contexture eCQM data</li> <li>• Must identify practice-driven target for each measure on reporting tool</li> </ul>
<b>CHP+ shared savings criteria</b>	<ul style="list-style-type: none"> <li>• Must report quarterly eCQMs to RMHP and the following eCQMs/NQF measures must be reported:             <ul style="list-style-type: none"> <li>• <b>Claims:</b> <ul style="list-style-type: none"> <li>- <b>W30a/b:</b> Well child checks in the first 15 and 30 months of life AND</li> <li>- <b>WCV:</b> Child and adolescent well-care visits</li> </ul> </li> <li>• <b>EMR (eCQMs)</b> <ul style="list-style-type: none"> <li>- <b>CMS 117:</b> Childhood immunization status</li> <li>- <b>CMS 2:</b> Depression screening and follow up</li> </ul> </li> </ul> </li> </ul>



### Reporting Reminders

- Report by primary care medical provider (PCMP) site location at the practice level, unless designated as a satellite for RMHP eCQM reporting purposes
- Report data for your entire patient population
- Reporting period YTD: Jan. 1, 2024–Dec. 31, 2024 or rolling year:
  - Quarter 1: April 1, 2023 - March 31, 2024
  - Quarter 2: July 1, 2023 - June 30, 2024
  - Quarter 3: Oct. 1, 2023 - Sept. 30, 2024
  - Quarter 4: Jan. 1, 2024 - Dec. 31, 2024
- Select all the programs that apply for your contracted PCMP locations at the top of the reporting tool
- Utilize the comment boxes for each measure if you are experiencing any reporting barriers/data discrepancies
- If your practice has chosen to submit a measure with multiple rates, please submit data for all parts to receive credit for the measure. Multi-part measures have 1 benchmark, and you must report on all parts of the measure to receive credit.
- If your EMR does not automatically account for exclusions/exceptions, please subtract them from the denominator prior to submitting. Our eCQM Reporting Tool does not subtract them.



### Quarterly practice report card

RMHP offers a quarterly practice report card that provides details on eCQM performance by program. If you are interested in receiving a report card, please check the box at the top of the Reporting Tool stating “Send practice report card”.

### Reporting schedule

<b>Quarter 1</b>	Due the third Friday in APRIL
<b>Quarter 2</b>	Due the third Friday in JULY
<b>Quarter 3</b>	Due the third Friday in OCTOBER
<b>Quarter 4</b>	Due the last day in JANUARY
