**IMPORTANT REMINDER:** All providers must revalidate the Medical Assistance (MA) enrollment of each service location every 5 years. Providers should log into PROMISe to check the revalidation dates of each service location and submit revalidation applications at least 60 days prior to the revalidation dates. ## **PURPOSE:**

The purpose of this bulletin is to:

- Remind Medical Assistance (MA) enrolled physicians, physician assistants (PA), and Certified Registered Nurse Practitioners (CRNP) that they can render topical fluoride varnish (TFV) services to MA beneficiaries.
- Remind providers of updated limits for procedure code 99188 on the MA Program Fee Schedule for the provision of TFV.
- Advise providers of the removal of mandatory TFV training requirements.

## **SCOPE:**

This bulletin applies to MA enrolled physicians, PAs, and CRNPs who render services to MA beneficiaries in the Fee-for-Service delivery system. Providers rendering services in the MA managed care delivery system should address any coding or billing questions to the appropriate managed care organization.

## **BACKGROUND:**

The Department of Human Services (Department) began payment to physicians and CRNPs for the application of TFV to MA beneficiaries under five years of age on April 1, 2010, as advised in MA Bulletin 09-10-08. This bulletin also described mandatory training that practitioners had to complete in order to be paid for applying TFV to MA beneficiaries.

On September 1, 2015, the Department advised physicians and CRNPs in MA Bulletin 09-15-14 of the requirement to use procedure code 99188 instead of D1206. On February 26, 2016, the Department provided physicians and CRNPs with the list of approved trainings available for the application of TFV in MA Bulletin 09-16-10.

On August 29, 2022, the Department advised physicians and CRNPs in MA Bulletin 99-22-05 that the age limit for procedure code 99188 was increased to age 20. On September 5, 2023, the Department advised physicians, PAs, and CRNPs in MA Bulletin 99-23-09 that the MA Program fee schedule limit for procedure code 99188 was increased to 6 per calendar year to align with the limitation for procedure code D1206.

### **DISCUSSION:**

The American Academy of Pediatrics (AAP) and the American Academy of Pediatric Dentistry (AAPD) recommend that children up to the age of 21 receive TFV treatments ([http://www.aapd.org/media/Policies\\_Guidelines/G\\_Periodicity.pdf](http://www.aapd.org/media/Policies_Guidelines/G_Periodicity.pdf)).

The Department supports the AAP's and the AAPD's recommendations regarding the application of TFV to beneficiaries under 21 years of age, as reflected in the Department's dental periodicity schedule (<https://www.pa.gov/content/dam/copapwp-pagov/en/dhs/documents/docs/publications/documents/forms-and-pubs-omap/MAB2023092801.pdf>).

To ensure that TFV is widely administered to MA beneficiaries and eliminate potential barriers, the Department is removing the requirement that the physician or CRNP who provides TVF complete an approved TFV training and submit a certification to the Department.

### **PROCEDURE:**

The Department encourages, but does not require, physicians, PAs, and CRNPs who provide TFV to be certified through the Society of Teachers of Family Medicine's no cost Smiles for Life continuing medical education course (<http://www.smilesforlifeoralhealth.org>, Course 6 - Fluoride Varnish).

### **SUPERSEDED BULLETINS:**
