

**Audiologic/Vestibular Function Testing Policy, Professional for Louisiana**

**Application**

**This reimbursement policy applies to UnitedHealthcare Community Plan Medicaid products.**

This reimbursement policy applies to services reported using the 1500 Health Insurance Claim Form (a/k/a CMS-1500) or its electronic equivalent or its successor form. This policy applies to all products and all network and non-network physicians and other qualified health care professionals, including, but not limited to, non-network authorized and percent of charge contract physicians and other qualified health care professionals.

**Policy**

**Overview**

This policy identifies circumstances in which UnitedHealthcare Community Plan will reimburse physicians or other health care professionals for audiologic/vestibular function testing to identify problems with balance or hearing.

**Reimbursement Guidelines**

UnitedHealthcare Community Plan reimburses for audiologic/vestibular function testing (CPT codes 92537, 92538, 92540, 92541, 92542, 92544, 92545, 92546, 92547, 92550, 92553, 92555, 92556, 92557, 92563, 92565, 92567, 92568, 92570, 92571, 92572, 92575, 92576, 92577, 92582, 92583, 92584, 92597, 92620, 92621, 92625) when one of the diagnosis codes are listed on a claim denoting problems associated with either balance or hearing. UnitedHealthcare Community Plan will not reimburse when the treatment rendered is without inclusion of one of the ICD-9/ICD-10 diagnostic codes being included on the claim accurately reflecting the member’s condition.

The attached procedure to diagnosis list was first derived by identifying areas of convergence across Center for Medicare and Medicaid Services (CMS) Local Coverage Determinations (LCD) and information received from various specialty societies.

**Questions and Answers**

<b>1</b>	<p><b>Q:</b> How was this reimbursement methodology derived?</p> <p><b>A:</b> The coding edits are based upon review of the Center for Medicare and Medicaid Service’s local coverage determinations and information received from various specialty societies.</p>
<b>2</b>	<p><b>Q:</b> Why are CPT codes 92552 and 92586 not included in this policy?</p> <p><b>A:</b> The hearing tests addressed in this policy are conducted for particular hearing conditions. CPT codes 92552 and 92586 are not included in this policy given the possible use of these codes for screening purposes in the pediatric population.</p>
<b>3</b>	<p><b>Q:</b> To determine reimbursement for reported CPT or HCPCS procedure codes, should ICD-9/ICD-10 diagnosis codes be reported at the claim level or claim line level?</p> <p><b>A:</b> Report ICD-9/ICD-10 diagnosis codes at the claim line level of the CPT or HCPCS procedure code to be considered for reimbursement.</p>
<b>4</b>	<p><b>Q:</b> Why are CPT codes 92588 and 92587 not included in this policy?</p> <p><b>A:</b> CPT codes 92588 and 92587 are addressed in UnitedHealthcare Community Plan’s Otoacoustical Emissions Testing Policy.</p>
